

MODERATOR SPEAKS

STAND UP IN DEFENCE OF OUR CHILDREN

AMONG the many serious social issues facing us at this time, the one that makes me sick in the stomach is the neglect and abuse of our children by parents and caregivers. Children are the treasures of our nation. But, what is the reality? The mindless abuse leading to their horrific deaths reveals the depth of the moral and spiritual degradation that exists in our society.

Why do we bring them into the world if we cannot take care of them?

This 1971 song made famous by the Carpenters becomes more real to me with the rise of child abuse and neglect. It says:

"Bless the beasts and the children: in this world they have no voice:

they have no choice. Light their way when darkness surrounds them: give them Love (pure love), let it shine around them. Give them

shelter from the storm; keep them safe; keep them warm."

The statistics of child abuse are sickening. A total of 27,437 cases of abuse were reported to the Children's Authority of Trinidad and Tobago for the period 18 May, 2015 and 28 February, 2021. Of this number, 9,713 or 35.4 percent of the abuse cases of children were inflicted by their mothers.

Of the remaining 17,724 cases, an estimated 11,112 or 40.5 per cent involved relatives or people known to the child victims.

And now we learn with dismay that a 1997 Report of a Cabinetappointed committee to investigate reports of abuse at children's homes and related matters had been kept from public view for 25 Understandably, persons were angry, appalled, and horrified that the revelations in this report were not acted upon and perpetrators brought to justice. Many are still confused as to the reasons for shelving such horrific findings. As one Newsday letterwriter wrote, "To sit on such information and allow these dastardly acts to continue for so many years is purely evil and demonic." I could not agree more.

It is our hope that the 2021 Report of the Justice Judith Jones committee on the same subject matter will not suffer the same fate. We urge the Government to implement this committee's findings in the shortest possible time.

We, in Trinidad and Tobago, observe National Child Abuse Prevention Month in April each vear. The focus is on families and communities working together to prevent child abuse. What role can the PCTT play to prevent abuse of children?

We need, as a church and nation. not only the restoration but the transformation of the family.

The fundamental values which create a civil society must be practiced in the home if our nation is to survive. The neglect and abuse of children are perhaps a reflection of the lack of parental skills and as well as the sorrows. the stresses, the weaknesses and the frustrations of the adult world.

The PCTT has a moral obligation to work with all stakeholders to develop child abuse prevention strategies and promote its prevention across the country. We must seek to educate our congregations and citizens on the nature of child abuse; to provide victims and families with resources to gain help and to remove the guilt and shame associated with child sexual abuse.

Children have a special place in God's kingdom. We are reminded, "Let the little children come to me: do not stop them; for it is to such as these that the kingdom of God belong" (Mark 10:14, NRSV). Let us, therefore, bless the children keep them safe!


THE EFFECTS OF OBSERVING VIOLENCE


One ancient view of drama is that the action on stage provides spectators with opportunity to release their own emotions harmlessly through identifying with the people and events depicted in the play. Those who share that view argue that filmed violence, far from leading to real violence, can actually have beneficial results in that the viewer may rid himself or herself of antagonistic impulses by watching other people behave aggressively, even if these people are merely actors appearing on a screen. On the other hand, there are those authorities of equal stature who argue that, filmed or staged violence, is a preparation for school delinquency. This view holds that emotionally immature individuals can be seriously affected by fighting or brutality in films or in their living

environment and disturbed young people, in particular, can be led into the habit of expressing their aggressive energies by socially destructive actions.

Initially. neither these of arguments had the support of data which were obtained through controlled experiments. Today. however, based on tests done with the support of the National Science Foundation (USA), one conclusion drawn is that the observation of aggression is more likely to induce hostile behaviour in normal people as well as by those who are emotionally disturbed. Associations between the screen and real world are important. People seem to be emotionally affected screenplay to the extent that they associate the events of the drama with their own life experiences. These findings have obvious social significance.

Have our educators considered the effects of filmed school violence shared through social media? What are the effects on students who see that aggressive behaviours which result in 'hero worship' and 'commanding respect' among their peers? Would they, then, conclude that displays of aggression and, the more violent the aggression, the more admirable or desirable? In our world today, and right here in our island Republic of Trinidad and Tobago, some of our students are exposed to 'live' violence on a daily basis. Measures need to be taken to halt that type of violent physical and verbal aggression not through more aggression but in home, in the school community. in the national community and through the speech and behaviours of our leaders. Our children are worth our collective effort to get them on the right track.

62ND SYNOD, AGM, 2022

After two consecutive Annual General Meetings (AGM) of Synod 2020 and 2021, which were held either virtually or hybrid, the 62nd Synod AGM 2022 was held in person at Naparima College's Auditorium from Thursday 28th April, 2022 to Saturday 30th April, 2022. This AGM marked 154 years of witness and mission of the Presbyterian Church in Trinidad and Tobago (PCTT). The theme was "Being the Church In and Beyond the Pandemic. What does the Lord require?" borrowing from the Scripture, Micah 6:8 "He has told you, O mortal, what is good, and what does the Lord require of you but to do justice and to love kindness and to walk humbly with vour God?"

The AGM was opened by the Moderator of Synod, the Rt. Reverend Joy Abdul Mohan. She was presented with a plaque by Board of Women's Chairperson, Reverend Moonoo, in recognition of her being awarded a National Medal for Women Development -Gold.

A new addition to the 1st day's proceedings was a feature address by Dr. Michael Dowlath, immediate past Principal of Naparima College, on the topic -"Being the church in and beyond the pandemic era, - moving forward with vision." Dr. Dowlath pressed on the need to critically analyse "The Perceived versus The Reality of the PCTT Today" in order to remain relevant going

On Day 2, a recommendation was accepted for Intern Minister

Robert Dinnoo's Ordination as Minister of the Word and Sacrament of the PCTT.




Aggression is one of the two primal emotions and curbing such has allowed for much research and experimentation. Not being able to control such an emotion has resulted in much chaos and mayhem. Outbursts in children of school age have again aroused interests by those in authority, therefore, it is vital that parents and caregivers have some basic knowledge in the development of anger from early childhood.

Psychologists, Stenberg and Campos, 1990, purport that anger is "thought to emerge developmentally around four months of age. It is more clearly

displayed as infants become stronger and more autonomous by nine months of age." (Lemerise and Dodge, 2000)

The ill-effects of anger can result in poor mental health from an early age and should be recognised so that there is a control of this emotion. What can parents and caregivers do to promote self-control of temperament?

My main belief is that an angry parent begets an angry child. Parents and guardians, you are the model for your child. Observe anger outbursts, then explore and practise positive parenting strategies.

Strategies to help children cope with anger issues:

When children becomes angry, it is important to work with them so that they can understand and better control their frustrations

• Help them spot the signs.

Make them aware that if their heart starts to beat faster, their muscles tense, their teeth clench or their stomach churns, this could be a sign that they are becoming angry. Helping them spot the signs early can give them the opportunity to make more positive decisions on how to handle it.

• Talk about helpful strategies. Encourage them to count to 10, walk away from a situation to calm down, breathe slowly and deeply, clench and unclench their fists in order to

manage their anger more effectively.

- Help them know where to turn. Let them know that there are people to whom they can turn to when a certain situation is causing them to feel angry.
 - Be positive.

Praise children for any efforts they make in order to build their confidence.

CRAMEN Baptism and Faith

As we continue to seek insights into the Sacraments: this month we will unravel Baptism and Faith and begin an overview of Baptismal Practices.

Baptism is both a gift from God and mankind's response to that gift. As stated by Paul in Ephesians 4:13, "... until all of us come to the unity of the faith and of the knowledge of the Son of God, to maturity, to the measure of the full stature of Christ." The baptized is expected to grow and be completely absorbed into Christ. Churches admit that faith is essential to receive the salvation embodied and brought about by baptism.

Baptism is not just an experience that lasts for a moment: it is a lifetime of growing and developing into Christ. Baptized individuals are called to show forth the glory of the Lord, as they are being transformed by the Holy Spirit into His image, with fervent and glorious praise. "And all of us, with unveiled faces, seeing the glory of the Lord as though reflected in a mirror, are being transformed into the same image from one degree of glory to another; for this comes from the Lord, the Spirit" (II Cor. 3:18). The life of a Christian is filled with struggles but in the middle of them the grace of God is experienced. In the relationship set in motion at baptism, the baptized now live for Christ, His Church, and for the world which He loves, while waiting with hope for the revelation of God's new creation and for the time when God will be their all in all.

"I consider that the sufferings of this present time are not worth comparing with the glory about to be revealed to us. For the creation waits with eager longing for the revealing of the children of God; for the creation was subjected to futility, not of its own will but by the will of the one who subjected it, in hope that the creation itself will be set free from its bondage to decay and will obtain the freedom of the glory of the children of God. We know that the whole creation has been groaning in labor pains until now; and not only the creation, but we ourselves, who have the first fruits of the Spirit, groan inwardly while we wait for adoption, the redemption of our bodies. For in hope we were saved. Now hope that is seen is not hope. For who hopes for what is seen?" (Romans 8: 18-24). [1]

As baptized individuals grow in the Christian faith, they prove that humanity can be renewed and liberated. They now have a shared responsibility to witness in the present age to the gospel of Jesus Christ. The witnessing to which they are called takes place among the gathered community, the Church and in the world. Within a faith community of witness and service. Christians acknowledge the full meaning of baptism "as the gift of God to all God's people."[2]

Baptism does not only call for personal sanctification, but also encourages Christians to struggle for the fulfilment of God's will in all of life. (Rom. 6:9ff: Gal. 3:27-28: I Peter 2:21-4:6).

Baptismal Practices

As the church developed throughout the ages, so did the practices of baptism. There are churches which practice "Infant Baptism" and "Adult Baptism" sometimes referred to "Believers Baptism." "Infant Baptism" also called "paedobaptism" the Greek 'pais' "child" and 'baptizein' "to baptize." Paedobaptism simply means the administration of baptism to infants. In Roman Catholicism, it is essential for salvation. In the Reformed Tradition, it is a symbol of God's grace.[3] Some churches baptize infants when they are brought by their parents or legal guardians who, along with the Church, are ready to nurture the children in the Christian faith. There are other churches which exclusively practice baptism adults/believers who can make a personal confession of faith. Some of these churches encourage the presentation and blessing of infants or children. This act is usually done at a service of thanksgiving for the gift of the children and dedication of mothers fathers to Christian and parenthood.

Adult/believers' baptism and infant baptism both take place when the faith community, the Church is gathered for worship. An integral part of the adult/believers' baptism service is the confession of faith that is declared by the person being baptized. When persons baptized as infants, their personal confession will be made later. In both adult/believers' baptism and infant baptism, individuals will have to grow in their knowledge of the faith. For persons baptized upon their own declaration of faith, there is always the need for growth in their personal response to faith. In the case of infants baptized, their personal confession of faith is to be made at a later time. To help them reach this point in their journey of faith, Christian nurturing must take place to bring forth this affirmation of faith. All baptismal practices are firmly grounded in Christ and affirms to His faithfulness unto death. Baptism is set within the life and faith of the Church, and through the witness of the believing community. points to God's faithfulness - the foundation of all life and faith. At every baptism service, the congregation re- affirms its faith in God's promises to create an environment of witness and service. Baptism, therefore, should always be celebrated and take place in the setting of the faith community at worship.

When the terms "infant baptism" and "adult /believers' baptism" are used, it is important to keep in mind that the real difference is between the church communities that baptize persons at any age and those who only baptize individuals who can make a confession of their faith for themselves. The differences between infant and adult/believers' baptism becomes less important when it is acknowledged that both forms of baptism represent God's initiative in Jesus Christ and a response made by the faith community.

"Persons who are less than fully competent mentally have often been fact that we should give careful ignored by the church, much to our shame"[4] Churches that administer Infant Baptism, have baptized infants their disabilities diagnosed. Learning of their disabilities the church reneges on its responsibility to nurture the child in the faith. In Churches where baptism is only performed at a later age, persons with disabilities have been overlooked while others of their age were initiated. Adults, with mental disabilities, who have requested baptism over and over have been prevented from being baptized because it is believed they do not have the mental capacity to understand what they are saying, much more, to express and live out the faith daily. Though the Church may not refer to persons with disabilities as "sub-Christians" their marginalization by church surely gives that impression. At times, condescendingly it is said that persons with disabilities are released from the customary requirements of faith, or they have a unique sort of faith that is different from that of other believers, thus baptism is not viewed beneficial in their circumstance.

Let us consider two facts: Firstly, the baptism of persons with disabilities may not only be helpful, but essential for the benefit of the whole church. The administration of baptism to persons with disabilities will push those who consider themselves "normal" persons to face the fact that divine love is for all humanity, not only for those of intellectual competence. The inclusion of those with disabilities into the congregation can be a channel of judgment and grace for members of fellowship. The degree spirituality displayed by persons with disabilities have exceeded the expectations of ministers and church leaders. The presence of persons with the disabilities within believing community can be edifying.

Secondly, is the more important thought to. Is that which lies behind the churches' Sacramental disregard of persons with disabilities, "A failure were to understand one thing distinguishes the Sacrament as from the more exclusively verbal and reasoned expressions gospel."[5] While the Sacraments use words, they function mainly at a level of action that can be understood visually, kinesthetically, and through the sense of touch and non-verbal sound; for example, when water flows or the wine is poured, as well as in music and through taste and smell in the acts that accompany the use of water being poured on at Baptism, and the pouring of the wine at Holy Communion. It is difficult to comprehend that God has chosen these as a means of communicating with persons with disabilities who cannot understand sermons or seize what is taking place at a study session.

> It is well known that persons with disabilities tend to be more visibly loving than many of us who consider ourselves normal. Maybe, God makes known the gospel to persons with disabilities in the laying on of hands, and the kiss of peace after the application of the water at baptism. If the church refuses to administer the Sacraments to persons disabilities because it is taught they do not fully understand what it is all about, the church may be denying them the means of grace that God has modified to meet their special needs. A serious review of the facts will reveal that it those of us who consider ourselves normal are the ones who do not fully understand what the Sacrament is all about. reconsideration of the baptism of persons with disabilities is crucial for the ministry of the church. A serious review of our opinion may change the present policies and practices of the church.[6]

CONGRATULATIONS TO DR. LESTER GOETZ SUBMITTED BY; JOY SAMMAH

Susamachar Pastoral Region extends hearty congratulations to our elder, Dr. Lester Goetz, for being conferred with a National Award, the Humming Bird Gold in the field of Medicine. A humble and generous servant and elder of the Susamachar Presbyterian Church, Dr. Goetz represented his alma mater, Queen's Royal College, at the school's drama festival and in the sports of hockey and swimming. He was also a Sergeant Major in the Cadet Force which instilled that discipline in him.

Dr. Goetz is married to the beautiful and devoted Ophelia and together, they have four children who all grew up actively participating in Sunday School, with the last daughter being a former Sunday School teacher.

Dr. Goetz did voluntary charitable work for the Cancer Society and the South Cancer Resource Centre, doing weekly prostate cancer screening. He assisted the Rotary Club of San Fernando West where he gave his time to conduct Voluntary health clinics. Incidentally, the Club won the Paul Harris award for these health clinics. Dr. Goetz is a founding member of the Trinidad & Tobago Urological Association and The Caribbean Urological Association, their first President respectively. He has represented the Caribbean on the International Relations Committee of the American Urological Association and as a member of the Editorial Board of the Canadian Journal of Urology and the Caribbean Medical Journal.

He is an examiner for new and upcoming doctors. He was a trial Examiner for the British Urological Association preparation for the FRCS Urology Exam. He has trained residents for the Postgraduate Urology Exam at UWI and was promoted to The Program director for the DM Urology at UWI and The first Senior Lecturer in Urology at UWI. He tutors to 4th and 5th year medical students.

He was Head of Department of Urology at The San Fernando General Hospital (SFGH) and while there, he introduced the first Dedicated Urology ward and the first dedicated Urology Theatre in T&T and in the English speaking Caribbean. He has organised 38 hands-on international workshops to train doctors in cutting edge Urology at SFGH, T&T and regional Urologists including those from Haiti.

Dr. Goetz was awarded Individual of the Year by the Ministry of Health and received awards from South West Regional Health Authority. As Medical Director/ Executive Medical Director at SFGH, he initiated the first Cardiac Ward in T&T at SFGH with a 40 percent drop in mortality. With his team he initiated an Oncology Suite at SFGH to provide chemotherapy for the first time at SFGH. He was also responsible in part for the start-up of a permanent GI service at SFGH.

He was President of T&T Medical Association in 2000 and has been the Organizer of the Medical Research conference annually for many years. Other awards include the Scroll of Honour and Research Award excellence in Urology by the Medical Association. The SFGH Urology Department recognized by The International Society of Urology as an official Training Centre for Urology in the Caribbean under Dr. Goetz' stewardship, having trained the majority of specialists Urologists in Trinidad at this time. He has also pioneered Laser surgery in Urology in Trinidad and the English speaking Caribbean.

What an impressive biography for a gentle soul! May God continue to shower His blessings on Dr. Goetz and his family.

Reverend Thomas Ali Hosein was honoured posthumously for his leadership in the construction of the St. James Presbyterian Church in Tableland one hundred vears ago, this was done during an Easter Thanksgiving and Praise service, on Apri, 17th 2022.

The Moderator of the Presbyterian Church, the Rt. Reverend Jov Abdul-Mohan. delivered the sermon while Presiding Elder Dennis Williams was leader of worship. At the end of the service a book on the history of the church written by former journalist and government minister, Mr. Harry Partap, was introduced. The book, A Sermon in Faith: The Historical Journey of the St James Presbyterian Church in Tableland, covered the period 1884 - 2022. It was introduced by retired senior journalist, Zorina Shah.

Five grandchildren of Reverend Hosein were present: Ms. Donna Latiff, Dr Wayne Haqq, Dr Russell Hosein. Dr Nigel Hosein and Gerard Hosier.

Reverend Abdul-Mohan is also related to Reverend Hosein. Dr Hagg received the plague from Local Board's Vice-chair Ms. Taramatee Loorkhoor. At the end of the service. Ms. Latiff planted a grafted Pommerac tree at the back of the church to mark the occasion. Local Board Treasurer. Ms. Urica Seepaul-Felmine. presented Reverend Abdul-Mohan with a box of locally grown produce.

Local Board Secretary, Ms Nazra Partap, welcomed the congregation which included the Chairman of the Princes Town Regional Corporation, Gowrie Roopnarine. Imam Fareed Mohammed of the Tableland Masjid and Pundit Rajendra Mohan of the Tableland Hindu Temple. Mr. Dave Puntai was honoured for his leadership in the construction of the present church building 34 years ago. Local Board Chairman, Mr. Trevor Phillip, thanked all who assisted in the work of the church since its establishment in the Tableland district 138 years ago.

In her Easter message, Reverend Abdul-Mohan noted that "we come to all our Easters by way of our Good Fridays." She said we were all living in a Good Friday world. She pointed out that the nations of this world "were staggering from one crisis to another in politics, economics and militarily." She observed, "It is a world anguished with tensions. viruses, violence of an old era dying while a new world with goals new lifestyles, priorities and systems struggle to be born."

She concluded that while the church must learn from its past history, it has to move forward in "re-visioning" itself to meet the tasks that lav ahead. and "The Church has to re-think its mission and improve its stewardship with a living hope. 



THE BOOK LAUNCH OF 'ADRIAN COLA RIENZI: THE LIFE AND TIMES OF AN INDO-CARIBBEAN PROGRESSIVE' BY BRINSLEY SAMAROO

On Saturday 14th May, 2022 at the Naparima College Auditorium, some of the members of the Archival committee gathered with others to celebrate the work of Adrian Cola Rienzi, through the words of Professor Emeritus Brinsley Samaroo. The title of the book is 'Adrian Cola Rienzi: The life and times of an Indo-Caribbean progressive'.

The Naparima alum introduced Rienzi as an "Indo-Caribbean progressive", as his work during the 1930s to the 1960s, resonates today.

He countered hate with love regarding discrimination against inter-racial marriages; "Love knows not race, nor birth nor creed" (2021, 9).

He equated women's empowerment with evolution; "those who do not keep astride with the other communities would not be able to claim equality and

He devoted his public service to the "upliftment of the Indo-Trinidadian population" (2) through advocacy for non-Christian movements. He was also a "constant liaison" between the British and Mahatma Gandhi (10).

His activism was pronounced during the uprising in 1937, as T. Uriah B. Butler's legal representative and the birth of unions in oil and sugar (92).

Professor Samaroo recommended socio-economic reform and reemphasized Rienzi's political youth empowerment. The 'Trinidad Presbyterian' was one of the publications that was an "organ for resistance" against the spread of an imperial idea, which influenced Rienzi's political activism (22).

Mr. Joel Simmons, President of the Naparima College Association of Past Students, closed the launch linking sentiments to the current digital context. He encouraged intergenerational dialogue around historical legacy and called for practices in preserving and promoting institutional legacy and memory through digital transformation.

Similar research and studies can be initiated at the Archives of PCTT.




depth of His love by washing the feet of the disciples.

THE THOUGHT OF SUICIDE (PART II) DR. DIANA NARINESINGH, PSYCHIATRIST, ARIMA PRESBYTERIAN CHURCH

You can't always tell when a loved is considering suicide. However, common signs include: talking (or posting on social media) about suicide e.g. " I wish I were dead", " I wish I was never born, "good-bye", becoming withdrawn and wanting to be left alone, changing normal routine-including sleep and eating habits, increase in use of alcohol and other drugs, firearm/ obtaining а rope/ poisonous substance/ stockpiling pills, giving away belongings, feeling trapped or hopeless about situation, mood swingsemotionally high then deeply

discouraged, developing personality changes or being severely anxious, depressed or agitated.

Many people who die from suicide endure deep psychological pain leading up to the act, but suicide may also be impulsive. Women attempt suicide more often, while men complete the act of suicide more frequently. Historically, in our predominantly agricultural society, methods such as ingestion of weedicide or pesticides were more common. In recent times, this

has shifted to other lethal means such as hanging possibly due to influence from social media and the internet.

We can all help prevent suicide. Mental health education and building resilience is a must from as early as lower primary school level. This starts at home, at school, the the community and nation Strengthening of economic supports, access and delivery of suicide care, creating protective environments, promoting connectiveness, teaching coping/problem solving skills and early identification of persons at suicide risk are some public strategies to reduce suicide risk.

Depression and other mental health conditions are treatable with use of medications. psychotherapy and other adjunctive methods e.g. meditation, prayer, exercise. abstaining from alcohol and other drugs, socialization, good sleep hygiene and fulfilling a sense of purpose. Misinformation regards to seeking mental health (especially the use medication) is flagrant, another barrier for treatment.

For far too long, generational misinformation of mental health has led to stigmatization leading to decreased access to care especially in men. As we soar through these uncertain times, open discussions and education about mental health and suicide is a priority. Too many have suffered and are suffering with the thought of suicide.
